#### Technology Transfer Centers Network (TTC)

The purpose of the Technology Transfer Centers Network (TTC) program is to develop and strengthen the specialized behavioral healthcare and primary healthcare workforce that provides substance use disorder (SUD) and mental health prevention, treatment and recovery supportservices. The TTC Network is comprised of the Prevention Technology Transfer Centers (PTTC), the Addiction Technology Transfer Centers (ATTC), and the Mental Health Technology Transfer Centers (MHTTC) and there is a PTTC, an ATTC, and a MHTTC in each of the ten HHS Regions.

#### Prevention Technology Transfer Centers (PTTC):

The PTTCs develop and disseminate tools and strategies needed to improve the quality of substance abuse prevention efforts; provide intensive technical assistance and learning resources to prevention professionals in order to improve their understanding of prevention science, how to use epidemiological data to guide prevention planning, and selection and implementation of evidence-based and promising prevention practices; and develop tools and resources to engage the next generation of prevention professionals. The PTTCs also provide technical assistance for American Indian, Alaska Native, Hispanic, and Latino populations.
